CONTRIBUTION

I have read and understood the conditions in the SPEC Personal Product Disclosure Statement about voluntary contributions. I declare that the information in this form is true and correct to the best of my knowledge and belief, and I understand that:

- limits apply to the amount of 'non-concessional' contributions that I can make each year;

- earnings on my account are not guaranteed by the Trustee Board of SPEC Super and may be positive or negative;
- I must satisfy one of the following criteria to be eligible to make voluntary contributions (cross relevant box):

I am under age 65;

I am 65 or over, but under 75, and have worked at least 40 hours in a continuous 30 day period in the current financial year.

Please note that limits apply to the amount of 'non-concessional contributions' you may make (which includes voluntary contributions you make on an after tax basis). The limit is \$150,000 per financial year. However, members under 65 may bring forward two years worth of contributions (\$450,000 in total). Please refer to the Contributions section of the Product Disclosure Statement for further details.

If you are self-employed, you can claim a full tax deduction for the contributions you make to the Fund. Refer to the Product Disclosure Statement for further information, including the limits that apply to 'concessional contributions' (which includes contributions you claim a tax deduction for).
